## Mini Movers

Approx 18months-3 years

All of the fun of jazz, ballet & creative movement in one 30 minute class. This class is for children as young as 18 months to 3.5 years of age who are taking their first steps into dance. This class is ideal for students who have a few years before going to school. Inspiring their creativity through dance and props and games your child will learn some of the basic fundamentals of dance. For this class only, parents are welcome to stay and watch.

## Twinkle Toes

Approx 3-5 years

# TERMS & CONDITIONS 2026

I understand that all fees are payable whether my child attends or not.

Fees are invoiced at the commencement of each term and MUST be paid within two weeks of the invoice issue date. Payments can be made either by EFT or cash (correct amount in an envelope marked with the students details.)

A late fee of \$5/week will be charged if this is not paid on time for each week overdue without a payment plan being placed.

A non-refundable payment for insurance and registration will be charged at the time of enrolment. Each student will need to enrol at the beginning of each calendar year and pay this fee. The current enrolment fee is \$35/student or \$45/family.

No parents/guardians/siblings are permitted to stay within the studio at any time during class, unless advised otherwise by our teachers.

Parents are to collect their child from the studio after each lesson. Teachers are not responsible for the students safety before or after class. Please talk with your children about safety and staying inside the premises. Please advise the studio of any family situations we need to be aware of.

Students are not to train in dance at any other studio without permission from the owner.

All outstanding fees must be paid in full prior to the end of year concert and costumes being distributed or the student will not be permitted to perform. No refunds will be given once costumes are paid for.

Alive Dance Academy accepts no responsibility for lost property or valuables. It is best to leave items these at home and not bring them to dancing.

No bullying or disrespectful behaviour will be tolerated at Alive Dance Academy. All students must treat their teachers and fellow students with respect at all times.

Any photographs/videos taken during class may be used for advertising/promotion purposes.

## **Liability Waiver**




